

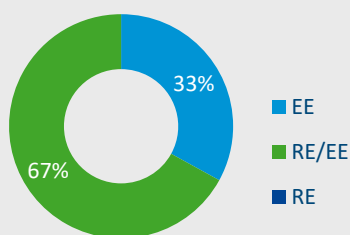

By product (in EUR million)



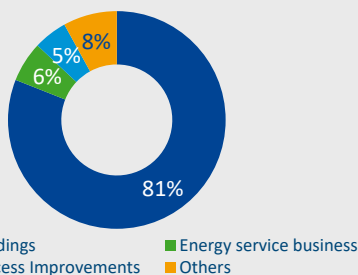
