

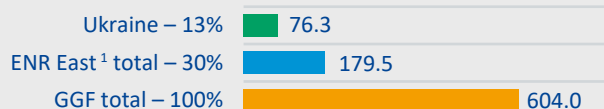
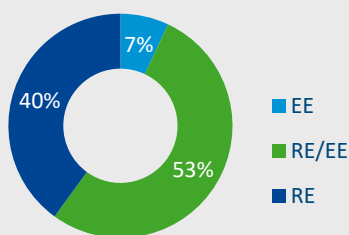

Investment Portfolio Outstanding and Committed

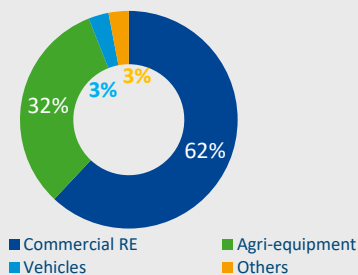
By product (in EUR million)
